

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to zFairs.com, NHD.org, NHDWebCentral.org, and Illuminating Software LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Illuminating Software LLC include zFairs.com, NHD.org, NHDWebCentral.org, Illuminating Software, zFairs and zFairs.com. By using the Illuminating Software website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Illuminating Software may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- School, Teacher, Grade, and other information determined by the sponsoring organization
